## 2018 Tournament Team Waiver

For the consideration of and to be eligible to participate in Four Leaf Fifteens ("The Tournament") as well as any associated events/activities on or about March 24, 2018, the Undersigned ("Participant(s)") agrees to affirm(s) the following:

1. That each participant must sign and agree to all terms of this agreement. That only those persons listed and signing below will be involved and participate in the tournament and related activities; and that, no person will participate in the tournament or related activities on behalf of the above named team that is not listed nor has signed below and that any unlisted or unsigned member of the above named team will be held from any tournament events/activities until he/she has executed this agreement.
2. That the Coach and/or Captain ensure that no players will participate in the Tournament without first executing this agreement. If any participant does take part in the Tournament without first executing this agreement, the Coach and/or Captain listed above will indemnify and hold harmless the Village Lions Rugby Football Club, the Tournament, Tournament Directors, and Tournament Sponsors from any and all injuries that may result to or be caused by the participant who did not sign this agreement.
3. That each and every participant, including Captains and Coaches, is/are currently registered through USA Rugby's membership enrollment program (CIPP), can confirm they are compliant with the terms of that membership, and would be deemed 'member in good standing' throughout the duration of the Tournament.
4. That each and every participant has a medical insurance policy in his/her name.
5. That each and every participant authorizes examination and treatment by staff at Fusion Physical Therapy & Sports Performance in the event the participant is referred to, or refers themselves to, services provided by Fusion Physical Therapy & Sports Performance on site at the Tournament.
6. That the sport of rugby by its' nature is a contact sport with a high level of hard physical contact; and that, participation in the sport of rugby creates a high risk of physical injury, serious physical injury, or death; and that, each participant enters this tournament voluntarily and with full knowledge of the inherent physical risks associated with the sport of rugby and fully assumes all responsibility for physical injury, serious physical injury, or death.
7. That each participant assumes and takes full responsibility for inspecting the fields, equipment, and facilities used for the tournament and related activities; and that, any participant upon finding anything deemed to be in an unsafe or unfit condition will report such condition(s) immediately to a member of the Tournament staff and refuse to play until the issue at hand is resolved; and that any unreported unsafe or unfit condition is deemed accepted by each participant and each participant has consented to participate under such condition(s) and as a result agrees that the Village Lions

Rugby Football Club, the Tournament, Tournament Directors, Tournament Sponsors, and Tournament staff, will not be held responsible for the unreported unsafe or unfit condition.

8. That each participant acknowledges and takes full responsibility for his/her own involvement in tournament activities, including participation in rugby matches and any and all related events, including, but not limited to: the awards ceremony and social activities preceding or following the matches, with the understanding that participation in these activities involves a risk of serious injury including, but not limited to: physical injury, serious physical injury, permanent disability, severe social, economic, and emotional losses, and death as well as a risk of loss, injury, or damage to personal property; and that, loss, injury, or damage to personal property, personal physical injury, serious physical injury, or death may come not only from the participant's own actions, inactions, or negligence, but also may result from the actions, inactions, or negligence of others, the rules of play, the inherent nature of the sport of rugby itself, conditions of the premises, and/or equipment used.
9. That each participant accepts full responsibility for any and all damages to self and/or personal property including, but not limited to: physical injury, serious physical injury, permanent disability, and/or death, loss or damage to personal property, loss of income or pecuniary gain, social, emotional, and economic loss and any and all other losses to person or property resulting from involvement in the tournament and all related activities.
10. Any and all disputes concerning this agreement or arising out of this agreement or participation in the tournament or related activities shall be resolved solely and exclusively by binding arbitration according to the then current rules of the American Arbitration Association in New York City, New York and any such arbitration must take place in New York City, New York. In any such arbitration, the substantive law of New York will apply.
11. This agreement is subject to force majeure, and is contingent on accidents, acts of God, weather conditions, regulations or restrictions imposed by any government or governmental agency including the New York City Parks Department, or other venue related access incidents beyond the control of the parties. If performance is prevented by any cause of force majeure, this agreement shall be void without penalty to either party for any such performance not delivered.

**I, the Undersigned, have read, understood, and agree to the terms listed above. I release the Village Lions Rugby Football Club, all Tournament Staff, and Fusion Physical Therapy & Sports Performance from liability for any loss or damage resulting or relating to participation in the tournament and all related activities.**
